# MODERNIZING WILDFIRE SAFETY AND PREVENTION ACT OF 2025

In 2024 alone, the U.S. had 64,897 wildfires, which burned a total of 8,924,884 acres. It's clear that we are in the midst of a wildfire crisis, and we must deploy the resources needed to meet this challenge. As a result, the Wildland Fire Mitigation and Management Commission developed 148 non-partisan policy recommendations to mitigate and respond to the ongoing crisis. This legislation is a **first-of-its-kind** package incorporating the Commission's expert-led policy recommendations on fighting wildland fire. This package provides a **once-in-a-generation** opportunity to meet the needs of the wildfire crisis.

# **Wildland Fire Workforce Development**

- Establishes a Middle Fire Leaders Academy to provide rapid training and certification for emerging wildfire and beneficial fire leaders.
- Creates a grant program for colleges and vocational programs to ensure consistent support for the fire mitigation, response, and recovery workforce.



# **Wildland Firefighter Support**

- Extends the break in service provision to two years to ensure that wildland firefighters can remain eligible for firefighter retirement eligibility.
- Allows wildland firefighters to not be penalized in how time worked counts for retirement.
- Authorizes a DOI Wildland Fire Management Casualty Assistance Program to provide assistance to loved ones of injured, ill, or deceased firefighters and support personnel.



#### Wildfire Smoke and Public Health

- Establishes a nationally consistent smoke monitoring and alert system to provide consistent, real-time information and forecasts on air quality impacts from wildland fire.
- Authorizes a human health risk assessment and best practices for worker exposure to wildland fire smoke.



## **Fire Mitigation and Technology**

- Allows compensations to producers for forage losses due to the use of beneficial fire to reduce wildfires.
- Develops dynamic risk maps for the wildland environment.
- Streamlines accessibility and deployment of federal wildfire grants.
- Establishes the Joint Office of the Fire Environment Center.
