6	Section 1886(h)(4)(H)(i) of the Social Security Act

3	"(bb) For purposes of item (aa), the
4	term 'cap building period' means the 5-
5	year period used to calculate the total ad-
6	justment of the limitation under subpara-
7	graph (F) for a hospital for a new ap-
8	proved medical residency training program
9	under the relevant provisions of para-
10	graphs (d) and (e) of section 413.79 of
11	title 42, Code of Federal Regulations, and
12	such other relevant provisions of such reg-
13	ulations (as in effect on the date of the en-
14	actment of this subclause).".
